This is to certify that the Commissioner – Highways has jurisdiction of the highways of the County of Erie and does hereby close that portion of the highway in the Town of Aurora, said County, known as Erie, and described as follows:

CLOSURE:

That portion of Grover Rd. (CR-373) from Sweet Rd. to Mill Rd. will be closed. The closure will begin on Monday, November 21, 2016 until Friday, November 25, 2016 or until complete. Closure is for the purpose of cross culvert repair. Union Concrete Construction will be doing the work. A signed detour will be in place.

Closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
