Nancy Smith and Jajean Rose-Burney from the WNY Land Conservancy and Attorney Beth Holden, from Hodgson Russ LLP, spoke to the Board about the revised property match (down to 98 acres from 138 acres) and restrictions on the Town's Major Park property for the grant the WNYLC is to receive from US Fish and Wildlife Service toward the purchase of property on the south side of Hubbard Road, currently known as Jackson Falls.

Mrs. Smith stated that the WNYLC has a meeting scheduled with Mark Thomas and Noelle Kardos from NYS Parks on Wednesday and she would like to be able to take an approved resolution to the meeting.

Councilwoman Jeffe stated that the Board appreciates the changes made and supports the outcome in principal, but still would like to see written authorization from the NYS Parks (SHPPO) that confirms the Town's agreement with them would not be "voided". Mrs. Jeffe said the Town needs an opinion from the NYS Comptroller, also.

Attorney Holden spoke about the Jackson Falls property being open to the public.

Councilwoman Friess stated she is still trying to get an understanding of the documents and maps that the Board just received today and that she has not had time to thoroughly review them.

Jajean Rose-Burney stated that everything, the areas, in the Major Park Master Plan have been excluded from the match and restrictions.

Councilwoman Jeffe asked what if the WNYCL changes? How do we know that 30 years down the road there will not be problems? Town Boards change and this proposal/resolution binds future Boards.

Supervisor Bach stated the Town needs to be indemnified.

Attorney Bennett stated he wants an opinion from the NYS Comptroller stating that it is okay to put restrictions on Town owned property that was paid for with taxpayer dollars. Mr. Bennett noted that the Town cannot give away control of land purchased with taxpayer money. He stated that he also would like an indemnification from the WNYLC regarding the restrictions.

Councilwoman Friess noted that the answer from the State Comptroller could bring up other issues or questions.

Councilwoman Jeffe asked Mrs. Smith if the purchase agreement deadline could be extended.

Attorney Bennett stated that if the Town Board approves the resolution prepared by the WNYLC then they are agreeing with the current sub-agreement and everything else.

Supervisor Bach said that his first job is to protect the Town based on the Town Attorney's advice. Mr. Bach asked if Mr. Bennett would prepare a summary of the Board's concerns.

Councilwoman Friess stated she would not personally sign something with so many unknowns.

Councilwoman Jeffe reiterated that the Board just received all the new/revised paperwork today.

Supervisor Bach stated he could speak with Mark Thomas and let him know the Town Board's concerns, and also let him know that the Board believes the Jackson Falls project is a good project.

Councilman Harris moved to adjourn at 8:25 p.m.; seconded by Councilman Snyder. Upon a vote being taken: ayes – five noes – none Motion carried.
