## Closure:

The closure will begin Thursday, June 22<sup>nd</sup>, 2017 at 7:00am until Thursday, July 20<sup>th</sup>, 2017 or until complete. The contractor is Occhino Corp at (716) 827-7000. Detour will be posted.

This closure is executed under Article V, Section 104A of the Highway Law in order to permit a proper completion of work of improvement thereon.
