WHEREAS, the HVAC controller system at the Town of Aurora Southside Municipal Center was in place prior to the purchase of the facility by the Town, and WHEREAS, the control system is a DOS based Andover system that lacks technical

support and is not compatible with today's technology, and

WHEREAS, the current system is failing and frequently does not allow control of the roof top HVAC units, and

WHEREAS, the Town is seeking an upgrade to the Andover system, and

WHEREAS, the sole authorized provider of Andover systems in Western New York and Northern Pennsylvania is U&S Services, Tonawanda, New York, and

WHEREAS, upgrading the Andover system with products of another brand is not possible due to incompatibility issues, and

WHEREAS, Municipal Home Rule Law Section 103(5) provides for the adoption of a Resolution by at least 3/5 of the members of the governing body of the Town for relief from standardization for a particular type or kind of equipment, and

NOW, THEREFORE, be it

RESOLVED, the Town Board of the Town of Aurora does hereby determine the need for standardization for the HVAC controller system at the Town of Aurora Southside Municipal Center. Due to the particular type of control system, it can only be provided by U&S Services, Tonawanda, New York, and be it further

RESOLVED, based upon the standardization, the Town of Aurora authorizes the upgrade of the Andover Controls System at the Southside Municipal Center and authorizes U&S Services, 233 Fillmore Avenue, Tonawanda, New York to provide and install the equipment and software necessary to upgrade the Andover Control System for the HVAC units at a cost of \$10,195, and be it further

RESOLVED, that the awarding of the control system to U&S Services based upon the need for standardization complies with the procurement policy and procedures adopted by the Town of Aurora.
