Supervisor Bach opened the meeting at 7:10 p.m.

Carl Widmer, Partner at Drescher & Malecki, LLP – auditors for the Town, spoke to the Board about the 2019 FY audit that was performed by his company. Mr. Widmer stated there were no reportable findings in their Management Letter. A risk assessed based audit was performed and a clean opinion issued by the auditors. Mr. Widmer stated that this is the 19th year in a row that the Town received a CAFR award.

Mr. Widmer discussed the Water, Highway, Part Town and General funds, noting that all had healthy fund balances, anything over 30% is considered healthy. He also noted that the Highway and Part Town funds rely heavily on sales tax revenue. Mr. Widmer noted that in 2020 the NYS Association of Counties is reporting a sales tax loss of over 23% at this time due to the Covid19 pandemic. Councilwoman Friess stated that sales tax revenue will be a challenge when preparing next year's budget.

STAFF REPORTS:

Tony Rosati stated the Zoning Board of Appeals would be meeting two evenings this week after not being able to meet for three months.

Highway Superintendent Gunner stated NYSEG will compensate the Town for rock placement near the Whaley Bridge project. Mr. Gunner also spoke about a serious accident on Behm Road near the former rail road track crossing, noting that it is an Erie County road, but the West Falls Fire Department may be coming to the Town Board to find out how to fix the situation that basically results in a ramp where the rail crossing was that sends vehicles out of control. Police Chief Krieger stated that there are many accidents caused by the "ramp" on Behm Road. He noted that there is a sign that says "bump", but it is more than a bump in the road.

Supervisor Bach stated he will contact Erie County Legislator Lorigo about the Behm Road situation.

Bill Kramer stated his department is issuing a lot of building permits.

Chris Musshafen stated that registration for recreation programs started today and programs are filling up.
