September 27, 2021

A meeting of the Town Board of the Town of Aurora took place on Monday, September 27, 2021 beginning at 6:50 p.m. immediately after the work session. The Board met in-person at the Aurora Municipal Center, 575 Oakwood Avenue, East Aurora, New York. The meeting was also streamed via Zoom and YouTube:

Supervisor Bach opened the regular meeting at 6:50 p.m., immediately following the conclusion of the work session. The Board addressed agenda items in the following order:

Councilwoman Jeffe moved to approve the minutes of the September Action #270 13, 2021 work session and meeting. Councilman Snyder seconded the 9/13/21 minutes motion. Upon a vote being taken: ayes – five noes – none aprvd

AUDIENCE I:

Robert Aronica, Boies Road, spoke to the Board about issues he is facing due to an ODA next to his property. Mr. Aronica stated neighbors should be notified so they are surprised by ODA development and that flag lots are becoming a problem.

David Peltan, Church Street, spoke to the board about the cannabis law, noting that this is an important event that will change our community and that there is a lot of research still to be done.

PUBLIC HEARING:

At 7:00 p.m. Supervisor Bach opened the Public Hearing on a Local Law proposing to extend the moratorium on certain development in Business (B) and Industrial (I) for three months. The notice was published in the East Aurora Advertiser and posted on the Town Clerk's bulletin board. The Supervisor asked if anyone wished to comment. Hearing no one, Supervisor Bach closed the hearing at 7:01 p.m.

> TOWN OF AURORA **LOCAL LAW 4 - 2021**

A LOCAL LAW, TO AMEND LOCAL LAW 1-1990 KNOWN AS "THE CODES OF THE TOWN OF AURORA", ADOPTED BY THE TOWN BOARD OF THE TOWN OF AURORA ON JANUARY 22, 1990, TO ESTABLISH A MORATORIUM ON CERTAIN DEVELOPMENT IN ZONING DISTRICTS B-1, B-2 and I.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF AURORA AS FOLLOWS:

SECTION 1. LEGISLATIVE INTENT

This Local Law amends a prior Local Law known as "The Town of Aurora Code" adopted by the Town of Aurora on January 22, 1990, as amended, relating to the administrative, legislative and general legislation of Codes within the Town of Aurora as therein set forth.

SECTION 2. PURPOSE

The Town Board of the Town of Aurora has under review regulations in regard to development in B1, B2 and I Zoning Districts within the Town of Aurora. It is acknowledged that Local Law No. 1-2021 previously established a six (6) month moratorium. Members of the Town Board have had numerous sessions reviewing the proposed code together with support of the Town Planning Board. The Town Board of the Town of Aurora finds it prudent and necessary to enact an extension to a moratorium applicable to the use of land and development in B1, B2 and I Zoning Districts in the Town. This moratorium extension is intended to ensure that no approvals for such land use application be granted or permitted until this Board can complete its planning studies and has had an opportunity to consider and enact appropriate regulations and/or appropriate amendments to existing laws. It is anticipated that the required code revisions shall be under consideration by the Town Board within the time-frame of the additional three (3) month moratorium.

SECTION 3. <u>AUTHORITY</u>

This Local Law is enacted pursuant to the provisions of Article 16 of the New York Town Law and Section 10 of the New York Municipal Home Rule Law.

SECTION 4. MORATORIUM AND DURATION

The Town Board of the Aurora hereby declares a three (3) month moratorium extension on the use of land and development in B1, B2 and I Zoning Districts within the Town in accordance with the directives of Local Law 1 - 2021.

SECTION 5. <u>SEVERABILITY</u>

The invalidity of any word, section, clause, paragraph, sentence, or part or provision of this Local Law shall not affect the validity of any other part of this Local Law which shall be given effect.

SECTION 6. <u>EFFECTIVE DATE</u>

This Local Law shall become effective immediately upon the adoption by the Town of Aurora Town Board and filing with the New York Secretary of State.

BUSINESS FROM BOARD MEMBERS AND LIAISONS:

Councilman Snyder congratulated Highway Superintendent Gunner of the clearing of the log jam in Cazenovia Creek. that the property is really cleaned up. Mr. Wochensky noted that the gardeners have requested a culvert pipe on the Majors Park property and the road from South Street needs fill. They are currently getting water from a neighboring property.

Supervisor Bach read a letter from the NYS Town Clerk's Association regarding the Registered Municipal Clerk certification (renewal) recently received by Town Clerk Martha Librock.

Supervisor Bach announced that the Town received a Safe Workplace Award from Comp Alliance and received a check in the amount of \$1,957.

Supervisor Bach announced receipt of a 90+ Cash Value Award from 3plus1 for a liquidity/cash management cash vest score of 90 or above for four quarters and thanked Kathleen Moffat for all her work with this.
