<u>976 Davis Rd. Site Plan application for Sprouting Minds Montessori School review and</u> recommendation - as presented by Sammie Trent, school owner

Don Owens asks if any exterior activities or site work will affect the existing drainage way on the property to which Ms. Trent answers no.

Doug Crow asks about attendance and why the need for the move (from existing Mill Rd. location)

Ms. Trent discusses the history of the school, which opened in 2017 for pre-K thru Kindergarten then expanded to elementary program in 2019. Currently37 students are enrolled with 80 on the waiting list. Ms. Trent would like to slowly expand to a maximum of 100 students (through 12th

grade). The school is outdoor focused, so the property size will suit their needs as well as the existing barn.

Doug Crow asks about traffic flow.

Ms. Trent explains student drop off times are staggered throughout the morning, and they plan to have the entrance to the driveway on Davis Rd. with one way traffic exiting onto Snyder Rd. Ms. Trent also explains that the school is New York State approved private school and no other approvals from the State are needed for them to move locations (yearly fire inspection required).

Discussion continues regarding the traffic flow, parking space requirement (14 per Town Code), bus requirements and sign permit requirements. Ms. Trent notes that most students are dropped off by family members because they come from many different surrounding towns and bus rides are lengthy. Liz Cassidy also confirms that the school is an allowable use for the zoning and Site Plan approval is required to make sure parking requirements are met.

Douglas Crow moved to recommend the Town Board approve the Site Plan application for Sprouting Minds Montessori School at **976 Davis Rd**. as submitted with the following condition:

1. Provide a grading/drainage plan for the parking lot (note elevations) so there is no adverse stormwater impact.
