A meeting of the Town Board of the Town of Aurora took place on Monday, September 26, 2022, beginning at 7:20 p.m. immediately after the work session. The Board met in-person at the Aurora Municipal Center, 575 Oakwood Avenue, East Aurora, New York. The meeting was streamed via Zoom and YouTube.

Deputy Supervisor Snyder opened the meeting at 7:20 p.m., immediately after the work session. Mr. Snyder stated that Supervisor Bach was attending the session via Zoom from Fort Stewart Florida and taking part in discussions but would not be voting on any of the motions.

The first item on the agenda was a public hearing on a request for a Special Use Permit for a dwelling group at 718 West Falls Road, West Falls, NY. Deputy Supervisor Snyder opened the hearing at 7:22 p.m. and asked if anyone wished to comment.

J. Gerard Green stated that he is the property owner and applicant and would like to build a single-family residence on the property that already has four rental units on it. Councilman Snyder noted that one of the units is listed as an Airbnb. Mr. Green stated he was not going to be doing that anymore. Code Enforcement Officer Cassidy noted that short-term rental is not defined in the Town Code and that the Town should consider a short-term rental code. Hearing no further comments, the hearing was closed at 7:24 p.m.

AUDIENCE I:

Kristel Dedrick, Olean Road, stated that the grant for the ROC playground was in the Buffalo News and she has a copy of that article. Frank Czerny, Director of ROC, stated that the intent was never to have a playground, just play therapy with movable equipment, not permanent. Councilman Snyder asked how many children would be there at one time. Mr. Czerny responded 30 to 35 in the summer. A discussion ensued as to the reason for the privacy fence as either to keep people from going on to the neighbor's property or to block sight and sound from a playground. Ms. Dedrick stated that the proper information needs to be presented to the Town Board and that she is looking out for herself, her family and her property.

Sam Reidy, Olean Road, stated he wants to see what trees would need to come down for a fence to go in and wants the Town to keep the 40 trees at its disposal to use at the end of the project if needed.

William Heidt, Ellis Drive, spoke to the Board as an owner of an Open Development Area property. Mr. Heidt stated that some ODA's do not meet today's ODA requirements and "grandfathering" does not seem to be the right thing to do. He noted that existing ODA parcels need to be heavily reviewed.
