A meeting of the Town Board of the Town of Aurora took place on Tuesday, October 14, 2014, at 7:00 p.m. in the Town Hall Auditorium, 300 Gleed Avenue, East Aurora, New York.

Supervisor Bach opened the meeting at 7:00 p.m. with the Pledge of Allegiance to the Flag. The Supervisor welcomed Officers Shane Krieger and Dustin Waldron of the East Aurora Police Department, along with Clip, the new police dog. Officer Krieger explained that Clip is already trained to detect narcotics. Officer Waldron will be Clip's handler.

The first item on the agenda was a PUBLIC HEARING on the use of Federal Community Development funds also know as Community Development Block Grant (CDBG). The notice was published and posted as noted by the Affidavits of Publication and Posting. Supervisor Bach opened the hearing at 7:07 p.m. and asked if anyone in the audience wished to address this topic. Hearing no one, the public hearing was closed at 7:08 p.m.

The Supervisor stated that the Town is looking to apply for CDBG funds for improvements to the Senior Center, including a permanent generator, window replacement and other building upgrades. This will be a joint application with the Village of East Aurora.
