AUDIENCE I

Al Kasprzak, Mayor of East Aurora, spoke to the Board about the closing of Knox Farm State Park. Mr. Kasprzak noted he had tried to contact state representatives to confirm the 12/31/10 closing date, but was unsuccessful in getting any responses. He feels that the Town and Village should step up and take over responsibility of the park.

Supervisor Jeffe thanked Mr. Kasprzak and noted that she is concerned with the closing as are the Aurora Arsenals and the carriage association.

WHEREAS, the Applicant has filed an Open Development Area application for a 3-Lot Open Development on a 15.3 acre parcel SBL# 164.00-1-40 located along with west side of Bowen Road, to the north of Woodland Drive; and

WHEREAS, the Applicant has made every reasonable attempt and all necessary effort to comply with specifications of Chapter 79 of the Code of the Town of Aurora; and
