RESOLVED, the applicants shall be responsible for maintaining an open and accessible right of way from Blakeley Road to the subject premises for the purpose of accommodating emergency vehicles, and be it further

RESOLVED, this Resolution shall be incorporated by reference into the application and approval of the Open Development Area permit.

RESOLVED, that said Open Development Area Plan for 2210 Blakeley Road is approved.

General Information

- With Village board approval, Tim Shaw, a P/T Public Safety Dispatcher for the department since April 2001, was hired as a F/T PSD with a start date of June 11th. With Tim's hiring from P/T and a pending P/T PSD resignation coming in June, we will be looking to hire 2 P/T PSD's in the coming weeks.
- In May the department was informed by the Town Judges that they have been directed to not arraign individuals without defense counsel present. Reportedly Erie County Assigned Counsel is working on having attorneys available who will represent defendants at their arraignments if they do not have an attorney. One idea the area judges are looking at is having a hub court, in Elma, where all off hour arraignments would take place for all towns on the eastern side of the county, hopefully that is not the final decision.
- Officer Brendon O'Hara received the 2017 Erie County Stop-DWI Award for EAPD. Officer O'Hara is well deserving of this award.
- The new dispatch printers were installed without issue.

Training:

- Lt Waldron attended Active Shooter Rescue Task Force Training
- All Officers have begun their monthly Manual test training. Everyone did well as
 expected, but again this will be an excellent ongoing refresher keeping everyone
 up to date with their knowledge of our rules and regulations.
