



The Village of Springville Board of Trustees is seeking an operating certificate to provide ambulance and EMS services in our community. The Village of Springville passed a resolution declaring that there is "public need" for EMS services.

The Village of Springville is applying for a Certificate of Need (CON) from the New York State Health Department Bureau of EMS and the regional EMS council to obtain the authority to operate an Advanced Life Support ambulance service in Springville. The application process requires the applicant to demonstrate "public need" for the issuance of a CON. The State EMS Council and the Department of Health define "public need" as:

> The demonstrated absence, reduced availability or inadequate level of care in ambulance or emergency medical service available to a geographical area which is not readily correctable through the reallocation or improvement of existing resources.

In addition to defining public need, the CON application process requires that letters of support be obtained from elected officials, public safety entities, and local healthcare institutions in order to demonstrate support for service. We are respectfully inviting you to provide a written statement in response to our application to obtain a CON. Please note that letters: 1. must be on organizational letterhead; 2. should reference an understanding of the definition of "public need" as set forth above; and 3, must be signed by the CEO or designee. We have included a draft letter of support for your reference to use or modify, as you desire. Please contact me if you would like the draft letter emailed to you in Word format.

We ask that you submit your letter of support to us as soon as possible as we intend to submit our application October 31, 2017. Please mail your letter to my attention at the address above.



#### **RURAL TRANSIT SERVICE 2016-2017 OVERVIEW:**




- ❖ As of May 31, 2017 RTS has a total of 1,698 registered clients and over 120 volunteers. Averages of over 10,000+ rides are provided by RTS volunteers on a yearly basis.
- ❖ At the March 2017 Board meeting a resolution was passed to purchase one new vans for the Aurora/ Elma / Marilla / Wales service areas. The van bid will be held in June 2017.
- ❖ Rose Stang (Boston Volunteer Driver) and Tom Frantz (Clarence Volunteer Driver) continue serving on the Advisory Board. In addition, Rose Stang serves on the Steering Committee.
- Brenda O'Neill, Executive Director continues to serve on the RSVP Advisory Board. The RSVP organization is dedicated to recruiting senior and retired individuals and matching them with volunteer opportunities at several WNY non-profit and human service organizations. Brenda is a member of VAWNY, Volunteer Administrators of Western New York. New this year, Brenda serves on the Erie County Senior Services Advisory Council.

- Sharon Stewart continues to represent Rural Transit as a member of SCCS, Southtowns Coalition of Community Services.
- On April 12, 2017, our Annual Volunteer Recognition Day was held at Michaels Banquet Hall and it was a huge success. Funds provided by the United Way, allowed all volunteers to receive a hoodie with the Rural Transit logo on it as a thank you for their outstanding volunteer service. Two volunteers received their 15 year pin, six volunteers received their ten year pin and nine volunteers earned their 5 year pins. In addition, eleven new volunteers received their first year of service RTS jacket.



- ❖ \$10,000 was awarded to RTS by the United Way for the 2016–2017 grant year. Funds were used toward fuel, repairs and client/volunteer recruitment.
- With funds from the United Way and CDBG, a new dispatch radio system was installed in all vans and offices for better communication.
- Cyndie Huynh resigned her position on the Board due to her limited availability.
- Kathleen Myers joined the Board of Directors in March 2017.
- Ruthann Rocque, Volunteer Coordinator resigned her position. Margie Phillips was hired as her replacement. She has a strong background with volunteer coordination.
- ❖ Our 2017 Ridership Survey was distributed in January. We received 110 responses. Eighty eight percent of participants indicated they can remain living in their own home with the assistance of Rural Transit. Eighty five percent of the applicants rated the service "very good" to "excellent." The comments written by the riders were a wonderful testament to the service.
- Dr. Diane Bessel, a professor at Damen University who specializes in Strategic Planning for small organizations will be working with the Board of Directors over the next year to put together our Strategic Plan.
- ❖ The RSVP Program Director, Pat Dowling has asked us to work with them to produce an informational video with Trellis Marketing. The focus will be to promote volunteerism with RSVP in Erie County. The video will be posted on Erie County's website and shown at every University Express Class. They may be able to air a shortened version on television. In addition, the Board voted to produce our own video to market Rural Transit Service. The filming will be held over the summer months.

- ❖ The National Volunteer Transportation Center has accepted a "passenger story" from one of our riders to be published in their book entitled Passenger Stories from the Road. Last fall, staff member Suni Stachura chose one of our riders, Joyce age 65 from Orchard Park to write her story on being a Rural Transit rider. This story along with 65 others around the country will be included in the publication.
- ❖ Rural Transit Service is the recipient of the Network in Aging Program of Excellence Award. We attended a lunch on November 2<sup>nd</sup> to receive this award.

#### **General Information**

- New P/T PSD Julie Tafelski's training is progressing well. Julie should complete her training shortly.
- While exploring the best solution for active shooter ballistic vests for our officers, I have found a "kit" that includes the vest and a ballistic helmet that will be in the allotted amount that was budgeted for the vests. For your information, the vests are different then the vests that the officers are required to wear whenever they work. The active shooter vests are two steel plates (front & back) that will stop high powered rifle rounds. These vests, in a carrier, would be put on over there other vests. The plan would be to have a kit in each of the five marked patrol vehicles.
- The Safety Committee is looking into the possible use of water filled vehicle barriers that would be used to block off streets for special events. The barriers are made of plastic, weigh about 100 pounds empty and when put in place, would be filled with water. When full the barriers would be able to stop a moving vehicle.
