## FIRST ADDENDUM TO LEASE AGREEMENT

This Addendum is attached to the current lease, effective January 1, 2014, between the Town of Aurora, 300 Gleed Avenue, East Aurora, NY 14052 and Fifth Avenue Catering, LLC, 300 Gleed Avenue, East Aurora, NY 14052, effective January 1, 2014 to terminate December 31, 2014. The following amendment is hereby made to the lease and is effective January 1, 2014:

1. Section 1. Premises. The lease for 128 square feet (8ft x 16ft) of space in the warehouse is hereby increased by 72 square feet effective January 1, 2014. The total new square feet of warehouse space to be leased is 200 square feet (10ft x 20ft).

- 2. Section 3. <u>Rent</u>. The provisions of section 3 remain the same with the exception of the increase in annual rent for warehouse space. The Lessee agrees to pay the Town EIGHT HUNDRED SIXTEEN DOLLARS (\$816) (at \$4.08/sq. foot) for warehouse space to be paid in equal monthly installments of \$68.00 payable in advance on the 1<sup>st</sup> day of each month by check made payable to the Lessor.
- 3. <u>Affirmation</u>. All other terms and conditions of the lease remain in full force and effect unless amended herein.
