The Village of East Aurora has requested assistance from the Town in treating ash trees in the Village to resist the Emerald Ash Borer since the Town has an employee licensed and certified to apply pesticides. Supplies for the project will be purchased by the Town from a sole source provider, John Deere Landscapes. The Village of East Aurora will reimburse the Town for the cost of the pesticide supplies.

Councilwoman Friess moved to approve the purchase of Arborjet Emerald Ash Bore Injection and Supplies from John Deere Landscapes, a sole source provider, in the amount of \$4,695.70 to be used by the Town's certified pesticide applicator for Village of East Aurora ash trees. Funds will be disbursed from A7110.444 Parks supplies and the Village of East Aurora will reimburse the Town for this expense. Councilman Snyder seconded the motion.
