We have denied your application because it violates our local zoning code that deals with accessory buildings and their placement on your property. According to Town Of Aurora Table Of District Regulations, Maximum Height for an accessory Building is 1 story not to exceed 15 feet to the mean of the roof. (The mean described as the mid-point between the ridge and the eaves, measured vertically.)

Required Mean Height = 15 feet Requested Height = 22 feet Variance requested = 7 feet






