LOCAL LAW \_\_\_\_-2015

A LOCAL LAW, INCREASING THE COMPENSATION OF THE

SUPERINTENDENT OF HIGHWAYS OF THE TOWN OF AURORA.

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF AURORA AS

FOLLOWS:

SECTION 1.

This Local Law is enacted pursuant to the authority of New York Town Law Section

27(1) regarding the compensation of the Superintendent of Highways, which section authorizes a

Town Board to increase the compensation of the Superintendent of Highways of the Town in an

amount in excess of the amount specified in the Notice of Public Hearing on the preliminary

budget for not more than one (1) year by local law pursuant to the Municipal Home Rule Law.

SECTION 2.

Pursuant to New York Town Law Section 32(1), the Town Board has the authority to

confer upon the Superintendent of Highways further duties as the Town Board may determine

not inconsistent with law. In accordance with this provision, the Town Board determines to

confer further duties in regard to the maintenance of the Community Center located at 300 Gleed

Avenue in the Village of East Aurora.

#### SECTION 3.

The compensation of the Superintendent of Highways of the Town of Aurora as specified in the sum of \$69,451.00 in the Notice of Public Hearing on the preliminary budget of the Town of Aurora for the year 2015, duly published pursuant to Section 108 of the Town Law of the State of New York be and the same is hereby increased in the amount of \$4100 payable biweekly in the amount of \$157.70. For the year 2015 this stipend will be pro-rated upon the effective date of the implementation of this Local Law.

#### SECTION 4.

In accordance with the provisions of Subparagraph h of Paragraph 2 of Section 24 of the Municipal Home Rule Law, this Local Law shall not become operative or effective unless and until thirty (30) days have elapsed after its adoption and no petition protesting against this Local Law signed and authenticated as required by said section has been filed with the Town Clerk of the Town of Aurora, or if such petition is so filed a proposition for the approval of this Local Law has been submitted at the next general election or a special election for that purpose pursuant to said section and received the affirmative vote of a majority of the voters voting thereon.

TOWN OF AURORA, A Municipal Corporation 300 Gleed Avenue East Aurora, New York 14052

hereinafter referred to as the "Lessor".

WINDHAM PROFESSIONALS 300 Gleed Avenue East Aurora, New York 14052

hereinafter referred to as the "Lessee", and

WHEREAS, the Lessor and Lessee made and entered into a certain Lease Agreement dated October 10, 2008, comprising certain leased premises located at 300 Gleed Avenue in the Village of East Aurora, New York, which Lease has been previously amended increasing the leased premises to 16,893 square feet, and

WHEREAS, the Lessee is desirous of leasing an additional 861 square feet adjacent to the present leased area, described as a suite 41 feet in length by 21 feet in width and to be referred to as Suite 2-G,

NOW, THEREFORE, the parties agree as follows:

- 1. <u>ADDITION TO THE PREMISES</u>: The Lessor hereby leases to the Lessee an additional 861 square feet of space within the facility as indicated on Exhibit "A" attached hereto, the total leased premises now being 17,754 square feet.
- 2. <u>RENT</u>: During the term hereof, the Lessee hereby covenants and agrees to pay the Lessor rent for the use and occupancy of the leased premises at the sum of \$20,026.45 per month effective (August 1,) 2015. The Lessee agrees to pay a fee

of \$32.94 per day for each day of (July) 2015 after the Certificate of Occupancy is issued for the additional 861 square feet.

3. <u>AFFIRMATION</u>: Except as amended by this Lease Addendum, the Lease remains in full force and effect in accordance with its terms.

The community pool was drained in early May to be bleached by the sun. It is in good condition despite our long and heavy winter. Opening day is June 13<sup>th</sup>.

Registration for summer programs continues with many programs beginning to fill. Orientation and staff training are scheduled in June.

It has been a busy month for me training many community members in CPR and lifeguard training. Baseball coaches were trained in CPR and how to use our new AEDs. East Aurora teachers and the Boys and Girls club were recertified in lifeguarding/CPR/AED. Lastly several teens are finishing up their blended learning lifeguard training in early June that started in the beginning of May.

EAST sent 24 swimmers to Tonawanda to compete in our first long course meet of the season. EAST is now ranked 25<sup>th</sup> out of all the teams from Syracuse to Buffalo, 13 places higher than last year.
